### **Board of Fire Commissioners passes fire levy lid lift resolution**

*Proposal to appear on the November general election ballot*

(Pasco, Wash.) – The Franklin County Fire District 3 Board of Fire Commissioners passed a resolution to place a fire levy lid lift on the November 7, 2023, general election ballot. The lid lift would fund additional firefighters to respond to higher call volumes and overlapping calls. It would also fund renovations at Station 33 to allow for 24-hour staffing.

Call volumes are up 49 percent and overlapping calls (two or more at the same time) happen 30 percent of the time. The fire district responded to 804 calls in 2022, of which 50 percent were for emergency medical service (EMS). Higher call volumes and overlapping calls are leading to longer response times. More calls are also driving up costs for medical equipment, firefighter protective gear, and other capital projects that are required to improve service.

“More firefighters and adequate facilities are necessary to respond to the growing demand for emergency services,” Fire Chief Mike Harris said.

If approved by voters, the fire levy lid lift will fund:

- One additional full-time firefighter
- Two seasonal firefighters for wildland fire season
- Firefighter gear, ambulance, and water tender replacements
- Station 33 on Columbia River Road (Block 1) renovations to allow for 24-hour staffing and decontamination facilities to protect firefighter health and safety
- Backup power at the main fire station to continue operations during a natural disaster

These improvements will reduce response times, improve service reliability districtwide and protect firefighters’ health and safety.

The fire district is asking voters to raise the fire levy from \$1.04 per \$1,000 of assessed property value to \$1.34. The \$0.30 lid lift would cost the owner of a \$300,000 home an additional \$90 per year or \$7.50 per month.
